Gentlemen:

Welcome to the 2007 golf season. Thank you for accepting our invitation to this opening event. The competition will consist of an 18 hole team better ball score in the AM and foursome (selected drives then alternate shot) for the PM round. The team with the lowest 36-hole score will be the Champions. There will also be a prize for the lowest score in the AM & PM rounds. The shotgun starting times will be 8:30AM & 1:45PM.

Following are items of information concerning this tournament and form a part of the conditions of the competition:

**REGISTRATION:** When you arrive at The Club at River Oaks, please check in at the Reception table, located in front of Golf Shop.

**LOCKER ROOMS:** The locker room, located on the lower level of the clubhouse, will be open for your use at 7:30AM.

**CARTS & CADDIES:** Golf carts will be mandatory and are included in the entry fee. **PLEASE DO NOT REQUEST A CADDIE OR CARRY YOUR OWN BAG. If you wish to have a caddie drive your cart, this is acceptable.**

**FOOTWEAR:** It is a condition of this competition that shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition:

**DISQUALIFICATION.**

**PRACTICE ROUNDS:** Practice rounds will be available on May 2nd & 3rd by calling the Golf Shop (860)-354-3330. The greens fees are courtesy of The Club at River Oaks. The cost of a cart for the practice is \$25.00 per team.

**PRACTICE RANGE:** Will be available at 7:30AM. Courtesy of CSGA.

**FOOD & BEVERAGE:** Lunch will be served between rounds in the clubhouse. The lunch is included in your entry fee. At the prize presentation, beer & wine will be offered courtesy of the CSGA.

**CELLULAR PHONE:** Use of a cellular phone or similar device by a contestant during the stipulated round is strictly **PROHIBITED.**

**DRESS CODE**: Contestants are required to adhere to the following guidelines:

- Shorts must be Bermuda length
- Shirts must have a collar and be tucked in at all times
- Jeans are not allowed
- Hats must be worn in a traditional manner

**Directions from:**

**Sherman Center** - take a left onto route 39 north (opposite the school), approximately 5 miles to route 55 east, go right approximately 1 mile and take a left onto Evans Hill Extension. Cross over bridge and proceed to River Oaks.

**Westchester County/New York** - take I-684 to end which becomes route 22 north, follow approximately 5 miles and make a right (at 6th traffic light) onto Haviland Hollow Road (Rt.68) and follow to the end. Make a left onto route 37 north and follow into Sherman Center. (follow Sherman Center directions)

**Danbury, Connecticut** - take I-84 to exit 7 and follow route 7 north to Gaylordsville then make a left onto route 55 west, follow approximately 1 mile to Evans Hill Extension on the right.
