THIS NOTICE TO PLAYERS SUPPLEMENTS THE LETTER TO CONTESTANTS AND THE CSGA LOCAL RULES AND CONDITIONS.

**FORMAT:** 18-hole stroke play qualifier. The players with the lowest 31 scores & ties, will advance to the Championship, to be played at Round Hill Country Club on July 28 - 30, 2008.

**TEES:** Play will be from the Black tees.

**HOLE LOCATIONS:** Hole location sheets are available at the reception table.

**YARDAGE MARKINGS:** There are red (100 yds.), white (150 yds.), & blue (200 yds.) discs in the fairway and marks on sprinkler heads for yardage to center of green.

**OBSTRUCTIONS:** Cart paths and worn areas in direct contact with them are deemed immovable obstructions. Relief is provided under Rule 24-2.

**LATERAL WATER HAZARDS:** marked by red stakes or lines

| Hole #1  | <b><u>RED STAKES ALONG LEFT SIDE. DISREGARD. THIS IS NOT A HAZARD FOR THIS EVENT.</u></b>  |
| Hole #3  | Left and angling deep into fairway (reachable from tee).   |
| Hole #4  | Right off tee. Also on left to the near corner of the trees (left of bunker).  |
| Hole #5  | Right and across fairway.  |
| Hole #9  | Left from the tee to the low point in the fairway.   |
| Hole #11 | <b><u>RED STAKES ALONG LEFT SIDE. DISREGARD. THIS IS NOT A HAZARD FOR THIS EVENT.</u></b><br>Small hazard between 11 <sup>th</sup> fairway and 12 <sup>th</sup> tee.<br>Right of green and continuing around back of green.  |
| Hole #13 | Small hazard to right rear of green. As an additional option to relief provided by Rule 26-1, there is a drop area to the right rear of the hazard.  |
| Hole #14 | Left and right, over hill to bottom of hole.<br>Also, near front of green on right.  |
| Hole #15 | <b><u>RED STAKES ALONG LEFT SIDE. DISREGARD. THIS IS NOT A HAZARD FOR THIS EVENT.</u></b>  |
| Hole #16 | Ditch starting on 10 <sup>th</sup> hole and continuing along left of 16 <sup>th</sup> tee.<br>Left, starting about 125 yards from green and around left and rear of green to service road through trees.<br><b><u>RED STAKES LEFT BETWEEN FIRST TWO HAZARDS DESCRIBED ABOVE. DISREGARD. THIS IS NOT A HAZARD FOR THIS EVENT.</u></b> |

Hole #16 Right, beyond break in tree line and right of cart path to end of hole.  
**RED STAKES ON RIGHT TO BREAK IN TREE LINE.**  
**DISREGARD. THIS IS NOT A HAZARD FOR THIS EVENT.**

Hole #18 Ditch in tree line on left.  
**RED STAKES ALONG RIGHT SIDE. DISREGARD. THIS IS NOT**  
**A HAZARD FOR THIS EVENT.**

**OUT OF BOUNDS:** Marked by white stakes & off club property.

Hole #2 Right and rear of green.

Hole #3 Left all the way past green.

Hole #4 Left, from near corner of trees to rear of green.

Hole #9 Left, from low point in fairway to green (**RED STAKES DEFINE OB**).

Hole #10 Left all the way past green.

Hole #12 Left and rear of green.

Hole #13 Left and rear of green. **WHITE STAKES ALONG LEFT SIDE TO**  
**GREEN. DISREGARD. THIS IS NOT OB FOR THIS EVENT.**

**GROUND UNDER REPAIR:** Areas enclosed by white paint plus:

Hole #2 Decorative planting area in front of forward tee. **MANDATORY**  
**RELIEF AREA. RELIEF MUST BE TAKEN UNDER RULE 25-1.**

Hole #6 On or across road behind green.

Hole #11 Note statement for hole #15.

Hole #15 Decorative planting area around tee. **MANDATORY RELIEF AREA.**  
**RELIEF MUST BE TAKEN UNDER RULE 25-1.**

**CONDITIONS:** Players are reminded that the following conditions are in effect:

Cellular phones, Footwear, Dress code

**PACE OF PLAY:** See the CSGA Pace of Play Guidelines. Please keep up with the group in front of you. We will watch the group behind you.
