### **General Information:**

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the CSGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

### **Schedule of Events:**

Monday, April 23, 2018 – Qualifying Round (18 Holes)

### **Qualifying Positions:**

Players with the **low 40 scores, including ties**, will advance to the 15<sup>th</sup> Russell C. Palmer Cup at the Country Club of Farmington on May 21<sup>st</sup> & 22<sup>nd</sup>, 2018.

### **Grouping & Starting Times:**

Starting times begin at 7:30am from the first tee.

### **Practice Round:**

Practice rounds are available to all players on a daily basis. To schedule a practice round, please call the Wallingford CC Golf Shop at (203) 284-9189. There is a mandatory cart fee of \$25 per qualifier participant for the practice round. You may bring caddies/guests for your practice round at a cost of \$50 per guest.

### **Registration:**

Players must check in at the player registration table located in front of the golf shop upon their arrival.

### **Format:**

18 holes of stroke play.

### **Practice Range:**

The practice range will be available for your use beginning at 6:30am. Please note that the range is strictly **irons only**. Balls are compliments of Wallingford Country Club.



***Caddies & Transportation:***

A player may carry his own bag, employ a caddie, or use a golf cart. While the use of a golf cart is permitted during the qualifier, the cost is not included in your entry fee. If you wish to utilize a golf cart, please check in with the Golf Shop upon your arrival. **The cost of the cart will be \$20 per player and must be paid in cash.**

***Attire:***

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

***Footwear:***

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.

***Food & Beverage:***

Food and beverage, **on a cash basis only**, is available at the Wallingford Country Club snack shack located next to the tenth tee. Players, caddies, and spectators are responsible for any food and beverage fees incurred during their round.

***Driver Heads & Golf Balls:***

The optional conditions as prescribed in Appendix I of the Rules of Golf are in effect.

***Withdrawals:***

You must contact the CSGA at (860) 257-4171 if you must withdraw from this qualifier. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions by the CSGA.
